Midland College (MC) signed and returned the funding certification and agreement form for the student portion (at least 50%) of the Higher Education Emergency Relief Fund (HEERF) allocation on April 25, 2020. MC has used, or intends to use the Emergency Financial Aid Grants to Students under the Coronavirus Aid, Relief, and Economic Security (CARES) Act funds to provide emergency financial aid grants to students affected by the disruption of campus closures due to the COVID-19 response.

An estimated 1054 MC students were eligible for the \$836,501 based on the following requirements:

- met eligibility requirements for Title IV funds based on a completed a 2019-2020 FAFSA
- was taking at least one face-to-face class prior to March 13, 2020
- was not fully withdrawn prior to March 13, 2020

Students meeting the requirements are qualified if they:

- complete the Midland College CARES online application https://midland.formstack.com/forms/cares\_application
- acknowledge need in one or more of the following areas:
  - 1. Food
  - 2. Housing
  - 3. Course materials
  - 4. Technology
  - 5. Health care
  - 6. Child care

Funds are disbursed based on the number of hours enrolled (not dropped) as of March 13, 2020, as indicated in the chart.

In addition to the above amounts, students enrolled in a face-to-face lab course that was did not transition to an online course, forcing the student to receive a grade of "incomplete" receives an additional \$200.

<sup>\*</sup>In June 2020, Administrative Council approved the release of extra funds to qualified students. Students that had received initial awards, were granted a second disbursement as stated above. Students eligible for funds after the increase where given the total amount for both awards.
