**Course Description:**

This course is an advanced study of the skills and techniques in managing early child care education programs. Prerequisite: CDEC 2328

- Use appropriate written and verbal communication skills
- Use the terminology of the occupation and the business/industry

11 Scenario Activities at 100 points each for a total of 1100 points. These will be graded on a rubric.

11 Lab Assignments at 20 points each for a total of 220 points. These will be graded on a rubric.

4 tests at 100 points each for a total of 400 points.

All assignments will be graded within 7 days of the due date. If for some reason, there is a delay I will alert you.
