



Midland College Homecoming Court Application

Homecoming at Midland College is an annual celebratory tradition in which students, faculty, staff, alumni, friends, and family gather to commemorate the outstanding achievements made by the Chaparrals. Through recognition of the Homecoming Court, MC honors those exceptional individuals who through exemplary performance have displayed an extraordinary commitment to leaving a legacy of pride.

THE HOMECOMING COURT

The Homecoming Court selection process begins with an application, which is completed by the individual being nominated. Based on verification of the information submitted on the application, names of candidates who are deemed **eligible** to appear on the official election ballot, will be posted on the window of the Student Life Office. All application materials **must** be received by posted deadlines in order for name to appear on official ballot.

Midland College's student body will participate in election in which the 5 candidates receiving the most votes from each category, King and Queen, will emerge as The Homecoming Court. The top candidate from each aforementioned category will be named King and Queen. In the event of a tie between King and Queen, a runoff election will occur.

CANDIDATE REQUIREMENTS

To run for Homecoming King, a student must be currently enrolled at Midland College, as a full time student. Student must have at least a 2.5 MC grade point average and cannot be on disciplinary probation.

To run for Homecoming Queen, a student must be currently enrolled at Midland College, as a full time student. Student must have at least a 2.5 MC grade point average and cannot be on disciplinary probation.

APPLICATION INSTRUCTIONS

- The application must be typed in 12 point font, double spaced, with 1" margins and black font.
- Please provide a header on the top of each page using last name, first name and page number
- Each section of the application must be clearly labeled with headings using the section headings below:
 - Section I Nominee Information
 - Section II Activities and Involvement
 - Section III Letter of Recommendation

Maximum: 1 page

A Letter of Recommendation by a Faculty member. The statement should outline:

- How long known Candidate
- Please list and describe (3) reasons why this candidate should be part of the homecoming court.

All sections of the application must be submitted in person to the Student Activities Office or emailed to sga@midland.edu no later than 12pm on **Wednesday, January 31, 2018**. Email submissions should be in PDF form.

Note: Video applications will not be accepted.
