

Welcome Summer Interns!

Thank you for inquiring about Midland College Summer Housing for non-student residence. We are hopeful that our services will meet your needs.

Housing for non-student residents will be offered in **Craddick Hall** from **May 20 to August 5, 2023**. We will not allow interns to move in to the residence halls prior to May 20. For cleaning, sanitizing and routine maintenance prior to the start of our fall semester, interns must vacate on or before August 5, 2023.

Rooms are reserved upon:

- Receipt of your application and copy of valid state driver's license or Passport
- \$20 Background fee + \$2,750 for *full* payment + \$200 Deposit (Total cost for summer housing \$2,970)
- Valid meningitis shot record (unless you are 23 years of age or older)
- Cleared background check (Anyone with a conviction for a felony, Class A Misdemeanor or Class B Misdemeanor, or pending charges at this level are ineligible to live on campus)

Room space is confirmed upon receipt of application, full payment and passing your background check. You will receive a confirmation email. Rooms are double occupancy and you will be housed with another intern. If you have an intern you want to room with let us know on the application.

If you will not be staying for the entire 11 weeks (May 20 – August 5), the rate is \$250 per week. We will be glad to provide you with the specific amount if you notify us in advance.

Check-in:

All residents are required to provide a receipt of FULL payment to the front desk of the residence hall at check in time. Please plan accordingly with the summer hours at Midland College. The summer hours are Monday – Thursday, 7:30am to 5:30pm. The cashier's office can be reached at 432-685-4531. FULL PAYMENT must be received prior to move in.

Check-out:

All residents, including summer interns are expected to check out properly as advised by the residence hall manager. Anyone who does not follow proper check-out procedures will be fined according to the housing rules and regulations, and Midland College reserves the right for any paid housing fees that might be refunded may be done at the catalog stated percentage rate depending on the time of move out based on the records of your proper check out.

Cost Information:

The total cost for summer intern housing is \$2,970 (includes \$20 background check fee – non-refundable, \$200 deposit – refundable based on room condition at move-out, \$2,750 housing use charge)

Housing costs include: room, utilities, and Wi-Fi. There are free laundry facilities located in the residence hall. Meals are not included, but can be purchased at the June and Frank Cowden, Jr. Dining Hall during operating hours.

This application becomes valid when completed and returned with: \$20 non-refundable background check fee, and \$1,375 down payment (the remainder of the balance (\$1,375) must be paid prior to move in) & \$200 deposit **OR** \$20 background check fee, \$200 deposit, and room payment of \$2,750 (can be made as one payment of \$2,970) made payable to Midland College and your shot record/form reflecting your meningitis vaccination and date received.

Failure to follow the Midland College Housing Rules and Regulations may result in dismissal from the residence halls and loss of deposit. The deposit (minus any damages/fines) will be refunded when the check-out process is complete. Refunds may take up to 90 days. A stop payment on a deposit check will result in a \$100 fine along with the college's processing fee.

DISCLOSURE REGARDING CONSUMER REPORT BACKGROUND CHECK

The Midland College Student Life Department may obtain information about you from a third party consumer reporting agency for campus housing purposes. All prospective residents must give written permission for a background check, and pay a \$20 non-refundable fee. Thus, you may be the subject of a “consumer report” which may include information about your character, general reputation, personal characteristics, and/or mode of living. These reports may contain information regarding your credit history, criminal history, social security verification, motor vehicle records (“driving records”).

You have the right, upon written request made within a reasonable time, to request whether a consumer report has been run about you and to request a copy of your report.
