- (3) Principal's Report
  - a. Back to School
    - Staff was trained last week on Curriculum, Hi Mama, and Daycare Licensing
    - Teachers have a few more home visits to complete before the first day
    - School day starts at 7:45 am
  - b. Staffing and Enrollment
    - 68 students have been enrolled for 21-22 school year 34- Head Start qualifiers out of 40 are enrolled 6 more spots available 5- Tuition students enrolled
      - 19- Afterschool daycare students enrolled
    - 1 teacher is out on maternity leave and 1 teacher resigned
    - 2 long term subs have been hired until permanent teachers are hired. One of the subs is almost finished with her certification and may take the permanent position as the teacher.
    - All assistant teachers' positions are filled and 2 part-time assistants have been hired.
  - c. Work in Progress
    - Students are required to spend 90 minutes of rigorous activity outside. We are waiting on bids for a shade structure. It will go up between the portables that way some of the time can be spent there as well.
