#### I. Welcome and Call to Order

Ms. Myers welcomed all and called the meeting of the Pre-K Sub Board to order at 4:10 p.m.

## II. Agenda/Approval of Minutes

The meeting minutes for the October 11, 2022 meeting were presented by Ms. Myers. Ms. Stewart motioned to approve the minutes as presented and it was seconded by Ms. Rivera. Motion passed.

## III. Dean's Report

#### a. Head Start Contract

For the Board's approval to continue the Head Start partnership, Dr. McKown-Yorkman presented the new Head Start contract. The contract renewal paperwork is completed each year in October, just before the fiscal budget year starts on April 1. An increased reimbursement rate per child, and an amendment approving one-time funding for items that will be placed in new Pre-K Academy building, were specific changes to this contract. Next year, the Midland College Pre-K Academy will service all eligible three and four-year-old Head Start children, by enrolling approximately ninety Pre-K Head Start students.

Ms. Myers presented a motion for approval of the new Head Start contract. Ms. Rivera motioned to approve and Ms. Stewart seconded. Motion passed.

## b. Financial Report

Dr. McKown-Yorkman presented Pre-K and Head Start South Plains Expenditure reports from September 1, 2022 through October 31, 2022. Head Start South Plains totaled \$1,477.84 in expenses with the majority being instructional supplies. Pre-K Academy had one expenditure of \$40.00 for employee fingerprinting.

# c. Quarterly Board Meetings

The Pre-K Sub Board Meetings will be held quarterly, according to Dr. McKown-Yorkman. Due to the Midland College Board meeting also being in December, December's meeting has moved to February.

The meetings are scheduled February and June for the 2022-2023 remaining school year. Meetings will be held on the second Tuesday of each month.

Dr. McKown-Yorkman announced there will be a new Board member at the February Meeting.

# IV. Principal's Report

## a. Staffing and Enrollment

Ms. Smith informed the Pre-K is fully enrolled with the required forty Head Start students. She has one hiring proposal for a part-time employee to be moved to a full-time position. A teacher's assistant position was available, but the applicant declined the offer. Ms. Smith noted she is hoping to have a part time position opening soon.

#### b. Initiatives

Ms. Smith announced there was a sizeable attendance for parent engagement during trick or treating. All but two students had one or both parents attend and participate.

Mr. John Trischitti will be the special reader for the Pre-K students on November 17, 2022. Mr. Trischitti has offered to bring books to give to students, on top of the books that are already provided.

# c. Beginning of Year: Head Start Requirements

Ms. Smith informed as of now the Pre-K has been without Ms. Jasmine Trevino, the Head Start Social worker. Ms. Smith stated she has been a really great support for students and parents.

Class Observations were completed. Ms. Smith will have more information for the next scheduled meeting, in February.

Curriculum Fidelity will start the week of November 14, 2022.

Ms. Smith stated BOY Progress monitoring is going well. Ms. Smith has started Professional Learning Communities, PLCs this year. Teachers are able to review data and pinpoint where students may need extra help academically and socially. This has been a positive addition and teachers have responded positively to the disaggregation of data.

The MOY assessments will begin in January.
